

Saints free broadband prize draw terms and conditions

Upon either (i) placing an order for toob full-fibre broadband on an 18 month home broadband contract using the promotional code saints50, or (ii) submitting the same email address which you used to place your order for toob full-fibre broadband on an 18 month home broadband contract into the form located at toob.co.uk/saints, you will be entered into the prize draw. The Prize is non-transferable and there will be no cash alternative available. There are 10 Prizes to be won.

Entries will only be valid if the property that the order for toob full-fibre broadband on an 18 month home broadband contract is placed for and which meets the requirements set out in condition 2 above is serviceable by toob and able to be activated by toob on or before 15/12/2023.
