

toob broadband: refer a friend prize draw terms and conditions



1. The prize draw is open to all UK residents aged 18 years or over. Employees of the Promoter, their families, agents or any third party directly associated with administration of the prize draw may not enter the prize draw.

3. Each person who meets the above requirements and:
